#### BY-LAW #2024-47

# A BY-LAW TO ESTABLISH RATES AND REGULATIONS FOR THE PARKING OF VEHICLES WITHIN

### THE TOWN OF WASAGA BEACH

**WHEREAS** the Council of the Corporation of the Town of Wasaga Beach deems it desirable and expedient to pass a By-law to regulate parking in the Town of Wasaga Beach;

**AND WHEREAS** Section 102.1 of the Municipal Act, 2001, S.O. 2001 c. 25, and O. Reg 333/07 enables a municipality to require a person, subject to such conditions as the municipality considers appropriate, to pay an administrative penalty if the municipality is satisfied that the person has failed to comply with any By-laws respecting the parking, standing or stopping of vehicles;

**AND WHEREAS** the Town has passed an Administrative Monetary Penalties System By-law;

**AND WHEREAS** Council has deemed that certain routine administrative and legislative powers are minor in nature, and the delegation of these powers would contribute to the efficient management of the Town while still adhering to the principles of accountability and transparency;

**NOW THEREFORE** this Council of the Corporation of the Town of Wasaga Beach hereby enacts as follows:

## 1 SHORT TITLE

1.1 This By-law shall be known as the "Parking By-law"

- 2 **DEFINITIONS**: For the purpose of this By-law:
  - 2.1 "Accessible Person Parking Permit" means a Parking permit issued to a Person with a Disability under the Highway Traffic Act, R.S.O. 1990, c. H.8 or a permit, number plate or other marker or device issued by a jurisdiction outside of Ontario and recognized under that Highway Traffic Act;
  - 2.2 "Accessible Person Parking Space" means a Parking Space provided under this By-law in accordance with the Integrated Accessibility Standards, Ontario Regulation 191/11, as amended, and identified by an Official Sign for the exclusive use of a Vehicle displaying an Accessible Person Parking Permit in accordance with the requirements of the Highway Traffic Act, R.S.O. 1990, c. H.8.
  - 2.3 **"AMPS By-law"** means the Town's Administrative Monetary Penalties By-law, as may be amended from time to time.
  - 2.4 "Bicycle Lane" means a designated portion of the street or roadway and is designed for one-way bicycle traffic only and denoted by pavement markings or signage;
  - 2.5 **"Boulevard"** means that part of a Highway that is not used, or intended to be used, for vehicular travel by the general public, and is situated between the travelled portion of the road and the adjoining property line.
  - 2.6 **"Bus"** shall mean any vehicle designed, licensed or used to transport 10 or more passengers or exceeds the length and/or width of a single municipal parking space and includes vehicles regulated under the *Public Vehicles Act*, or similar legislation;
  - 2.7 "Crossover" shall mean that (a.) part of a highway at an intersection that is included within the connections of the lateral lines of the sidewalk on opposite sides of the highway measured from the curbs or, in the absence of curbs, from the edges of the roadway; or (b.) any portion of a roadway at an intersection or elsewhere distinctly indicated for pedestrian crossing by signs or by lines or other markings on the surface;
  - 2.8 **"Curb"** shall include the edge of the travelled portion of the highway or limit that separates public property or space from private property or space (parcel).

2.9 "Director" means the General Manager – Development Services, or his/her designate or successor;

- 2.10 "**Display**" for the purpose of a resident parking permit means to be hanging on the rear-view mirror or placed on the driver's side of the dashboard as a prominent exhibition of proof of payment for parking or a sign in a place where it can be easily seen.
- 2.11 "Electronic Payment" means a confirmed purchase of a predetermined amount of "validation parking time" in any municipal lot' for the stated purchase period subject to lot closure times periods or non-availability of certain lots from time to time for Town approved purposes nor does it guarantee a lot parking space will be available. Cannot be used as validation for parking in any municipal parking space at on-street locations.
- 2.12 "Electronic Payment "App." means the electronic computer program that is supplied to the public and Town by a 3rd Party and is accessed by the user of the internet to purchase authorized parking "Validation Time" for one identifiable license plate that is selected by the purchaser. The program identifies or accepts location inputs to establish the correct parking rate per hour, or portion thereof, to purchase "Validation Time" and then calculates and establishes the correct expiry time for the purchase event for the license plate requested by the user at the time of purchase.
- 2.13 **"Electric Vehicle"** means, a battery electric vehicle that runs only on a battery and an electric drive train or, a plug-in hybrid electric vehicle that runs on a battery and an electric drive train, and also uses an internal combustion engine;
- 2.14 "Electric Vehicle Charging Station" shall mean any facility or equipment that is used to charge a battery or other energy storage device of an Electric Vehicle.
- 2.15 "Heavy Vehicle" means a Commercial Motor Vehicle having attached hereto a truck or delivery body and includes ambulances, hearses, casket wagons, fire apparatus, trailers, tow trucks, recreational vehicles, buses and school buses, and tractors used for hauling purposes on a highway;
- 2.16 "Highway" includes a common and public highway, street, boulevard, court, centre, crescent, avenue, parkway, driveway, square, place, lane, bridge, viaduct or trestle, any part of which is intended for or used by the general public for the passage of vehicles and includes the area between the lateral property lines thereof;

2.17 "Intersection" means the area embraced within the prolongation or connection of the lateral curb lines, or if none, then of the lateral boundary lines of two or more highways that join one another at an angle, whether or not one highway crosses the other;

- 2.18 "Over-size Vehicle" means any vehicle that exceeds the length and/or width of a single municipal parking space or extends beyond the limits of two abutting parking spaces, oriented on the longest access, but does not include a passenger vehicle with attached trailer that when it does not occupy more than two (2) physical parking spaces.
- 2.19 **"Park or Parking"** when prohibited, means the standing of a vehicle, whether occupied or not, except when standing temporarily for the purpose of and while actually engaged in loading or unloading merchandise or passengers;
- 2.20 **"Parking Lots"** when referred to in this Bylaw, shall be legally described as shown on Schedule "A" attached hereto and forming part of this By-law.
- 2.21 "Parking Space" means a portion of the surface of a highway or parking lot as indicated by the lines marked out on the paved surface for the parking of vehicles:
- 2.22 "Parking Ticket Dispenser" means a device that an electronic payment method is completed and, a timing mechanism shall indicate the actual time to which parking is allowed and will dispense a Validation Ticket which will indicate the date, amount deposited and time to which use of a parking space has been paid for;
  - 2.22.1 Notwithstanding the definition of a Parking Ticket Dispenser set out above, any reference to a Parking Ticket Dispenser in this By-law shall, alternatively mean and include, a purchase made by use an Electronic Payment "App." for a specific license plate being displayed on a vehicle where the e-mail receipt and electronic purchase record available to the Town will be also deemed to constitute a Validation Ticket.
- 2.23 **"Private Property"** means where the owner or authorized agent of a property has provided to the municipality a letter authorizing the enforcement of this Bylaw on a property by a Municipal Law Enforcement Officer of the municipality;
- 2.24 **"Rate Plate"** means the plate attached to the parking meter or parking ticket dispenser specifying the rates and times applicable;

2.25 "Recreational vehicle" means any motor vehicle or trailer used for recreational purposes including but not limited to boating, camping and land/water sports;

- 2.26 "Residence Address" for the purpose of a resident parking permit, means the municipal street address assigned for a registered property and includes the leased modular home site address assigned by property owner;
- 2.27 "Resident" for the purpose of a resident parking permit, means the occupant or registered owner of a property within the Town of Wasaga Beach as confirmed by a current year tax bill or valid photo identification issued by the Province of Ontario and shall include a person that is resident of a modular home as defined in the Town of Wasaga Beach Zoning By-law, and as confirmed by valid photo identification issued by the Province of Ontario;
- 2.28 "Resident Parking Permit" means a permit issued by the Town of Wasaga Beach to a qualified resident;
- 2.29 "Stop" or "Stopping" when prohibited, means the halting of a vehicle, even momentarily, whether occupied or not, except when necessary to avoid conflict with other traffic or in compliance with the directions of a police officer or of a traffic control sign or signal;
- 2.30 "Trailer" means a vehicle that is at any time drawn upon a highway by a motor vehicle, except an implement of husbandry mobile home, another motor vehicle or any device or apparatus not designated to transport persons or property, temporarily drawn, propelled or moved upon such highway, and except a side car attached to a motorcycle, and shall be considered a separate vehicle and not part of the motor vehicle by which it is drawn;
- 2.31 "Unauthorized Area" means boulevard, front yard or side yard, excluding a driveway;
- 2.32 **"Vehicle"** includes a motor vehicle, motorcycle, motor-assisted bicycle, traction engine, farm tractor, road building machine, trailer, and any vehicle drawn, propelled or drawn by any kind of power, but does not include a motorized vehicle or the cars of electric or steam railways running only upon rails;

## 3 PROHIBITED PARKING:

3.1 <u>In Specified Places</u>: No person shall park a vehicle in any of the following places:

- 3.1.1 on or over a sidewalk;
- 3.1.2 on or over a boulevard;
- 3.1.3 within 3 metres of a point on the curb or edge of the highway adjacent to a fire hydrant;
- 3.1.4 in such a manner as to obstruct traffic;
- in such a manner as to interfere with the movement of traffic or the clearing of snow from the Highway;
- 3.1.6 on or over a designated pedestrian crossover;
- 3.1.7 within an intersection;
- 3.1.8 within 9 metres of an intersection unless otherwise indicated by a sign;
- 3.1.9 for the purpose of displaying the vehicle for sale;
- 3.1.10 in front of or within 1.5 metres of the entrance to a public lane or private driveway, or so as to prevent ingress or egress to or from such lane or driveway;
- 3.1.11 on any bridge or within 100 metres of a bridge over, under or across which the highway passes;
- 3.1.12 a heavy vehicle on any highway or parking lot, except for the purpose of and while actually engaged in loading or unloading, but not to obstruct traffic;
- 3.1.13 on any highway unless on the right side of the highway, having regard to the direction in which the vehicle had been proceeding, with the right front and right rear wheels not more than 0.15 metres (15 centimeters) from the curb or boundary of the roadway or as near as the condition of the street permits;
- 3.1.14 where proper signs regarding prohibited parking have been erected and are on display, no person shall park a vehicle in any parking lot listed in Schedule "A" or on the side of the highway where signs are erected as listed in Schedule "B" attached hereto and forming part of this By-law.

3.1.15 in such a manner as to interfere with the clearing of snow. For clarity, and without limitation, if a snow clearing vehicle must change its course to avoid a parked vehicle, or is prevented from entering an area it would otherwise have entered to clear or plow snow or ice because of a parked vehicle, that vehicle is deemed to be interfering with the clearing of snow;

- 3.1.16 between the hours of 1:00 a.m. and 7:00 a.m., during the time period from November 1st of any year to April 1st of the following year;
- 3.1.17 where proper signs regarding prohibited stopping have been erected and are on display, no person shall stop a vehicle in any parking lot listed in Schedule "A" or on any portion of any highway listed in Schedule "B" attached hereto and forming part of this By-law.
- 3.1.18 on any street a trailer, a semi-trailer, mobile equipment or any recreation vehicle which may be detached from the vehicle which is used to draw it;
- 3.1.19 on an unauthorized area, except as authorized by this By-law;
- 3.1.20 on any area where spaces are designated by lines painted on the roadway or where marked off by other means to prohibit parking in a closed area.
- 3.1.21 In an electric vehicle charging station that is identified by a sign and/or ground markings that satisfies the prescribed requirements unless the vehicle is an electric vehicle and the vehicle is attached to the station's charging equipment/station.
- 3.2 Where proper signs regarding Tow-Away Zones have been erected and are on display, no person shall park a vehicle in any parking lot or on the side of the highway where signs are erected as listed in Schedule "B" attached hereto and forming part of this By-law;
- 3.3 Where proper signs regarding Fire Routes have been erected and are on display, no person shall park a vehicle in any parking lot or on any portion of any highway listed in Schedule "B" attached hereto and forming part of this Bylaw;
- 3.4 No person shall Park, Stand or Stop a Vehicle in an Accessible Person Parking Space, unless a valid Accessible Person Parking Permit is displayed in accordance with the requirements of the Highway Traffic Act.

3.5 No person shall park any vehicle in any parking lot or highway or part thereof described in Section 4.1 and 4.2, between the hours of 2:00 a.m. and 8:00 a.m. daily where appropriate sign stating "No Parking 2:00 a.m. to 8:00 a.m." have been erected and are on display;

- 3.6 Where a lane of the highway has been designated for the use of bicycles only, no person shall park a vehicle in the designated lane other than a public transit, police, fire, emergency medical service vehicle or maintenance vehicle while engaged in maintenance activities.
- 3.7 Where proper signs regarding buses and over-size vehicles have been erected and are on display, no person shall park or stop any Buses or Over-size vehicle in the Municipal Picnic Area or in any Municipal Lot located in the main beach areas 1 & 2, being any lot affronting Spruce Street, Beach Drive, 1st thru 6th Streets and Mosley Street, except in Nancy Lot, described in Schedule "A", where parking shall be regulated.
- 3.8 Notwithstanding Section 4.14 of this By- Law, no person shall park a bus or over-size vehicle in the Nancy Street Lot, as described in Schedule "A", between the hours of 8:00am one day to 2:00am the next day, daily, unless the driver of such vehicle purchases two all-day parking permits from the Parking Ticket Dispenser and displays in front windshield or side driver's window, where they are clearly visible from the ground beside the vehicle.

#### 4 RESTRICTIVE PARKING:

- 4.1 No person shall park a vehicle, on a highway or part of a highway as listed below, between the hours of 7:00 a.m. one day to 2:00 a.m. the next day, daily, unless the driver of such vehicle deposits on the Parking Ticket Dispenser provided for the parking space the amount specified in the current Fees and Charges By-law.
  - 4.1.1 First Street east from Beach Drive to Mosley Street;
  - 4.1.2 Second Street (east side) from Beach Drive to Mosley Street;
  - 4.1.3 Second Street (east side) from Beach Drive to Mosley Street;
  - 4.1.4 Third Street (east side) from Beach Drive to Mosley Street;
  - 4.1.5 Spruce Street (west side) from Beach Drive to the intersection of Mosley Street and Main Street;
  - 4.1.6 Lewis Street (both sides) from River Avenue Crescent to Glen Street.

4.2 No person shall park a vehicle on a highway or part of a highway as listed below between the hours of 7:00 a.m. one day to 2:00 a.m. the next day, daily unless the driver of such vehicle deposits in the Parking Ticket Dispenser provided for the parking space, the amount specified in the current Fees and Charges By-law.

- 4.2.1 Beach Drive (south side) from Main Street to Third Street;
- 4.2.2 First Street (west side) from Beach Drive to Mosley Street;
- 4.2.3 Third Street (east side) from Beach Drive to Mosley Street.
- 4.3 Notwithstanding Subsection 4.4 of this By-law, no person shall park any vehicle in any municipal parking lot between the hours of 8:00 a.m. one day to 2:00 a.m. the next day, daily, unless the driver of such vehicle deposits the amount specified in the current Fees and Charges By-law, into the Parking Ticket Dispenser, and a Validation Ticket will be issued by the Dispenser.
- 4.4 Notwithstanding Subsection 4.4 of this By-law no person shall park any vehicle in the "#130 Main Street Parking Lot" or the "175 Main Street Parking Lot" between the hours of 8:00 a.m. one day to 2:00 a.m. the next day, daily, unless the driver of such vehicle deposits the amount specified in the current Fees and Charges By-law into the Parking Ticket Dispenser, and a validation ticket will be issued by the Dispenser.
- 4.5 Notwithstanding Subsection 4.4 of this By-law no person shall park any vehicle in the "**Dunkerron Avenue Lot**" between the hours of 8:00 a.m. one day to 2:00 a.m. the next day, on Saturday or Sunday or Statutory Holiday, unless the driver of such vehicle deposits the amount specified in the current Fees and Charges By-law, into the Parking Ticket Dispenser, and a validation ticket will be issued by the Dispenser.
- 4.6 Notwithstanding Subsection 4.4 of this By-law, no person shall park any vehicle in the "MUNICIPAL OFFICE LOT" between the hours of 8:00 a.m. one day to 2:00 a.m. the next day, on Saturday or Sunday or Statutory Holiday, unless the driver of such vehicle deposits the amount specified in the current Fees and Charges By-law, into the Parking Ticket Dispenser, and a Validation Ticket will be issued by the Dispenser.
- 4.7 No person shall park a vehicle on a highway described in Subsection 4.1 or 4.2, or in any municipal parking lot unless the driver of such vehicle places the Validation Ticket issued by the Parking Ticket Dispenser face up on the dash of the vehicle, on the driver's side, so as to be visible from the outside of the vehicle to indicate that the parking is paid for.

4.8 No driver of a vehicle shall allow such vehicle to remain parked on a highway as described in Subsection 4.1 or 4.2 or in a municipal parking lot unless said vehicle is displaying valid Ticket issued by the Parking Ticket Dispenser.

- 4.9 No driver of a vehicle shall allow such vehicle to remain in a parking space for a longer period than the time stated on the rate plate.
- 4.10 No person shall park any vehicle in such a manner that said vehicle is not completely within one parking space as indicated by the lines marked out on the paved surface of the parking lot or highway.
- 4.11 No person shall without lawful authority attempt to or in fact alter, deface, injure, knock down, or remove any official parking control device.
- 4.12 No person shall without lawful authority repair, service or paint a vehicle parked in any municipal parking lot or on any portion of any highway listed in Schedule "B".
- 4.13 Notwithstanding the definition of vehicle in Section 1 of this By-law, and notwithstanding any other section of this By- Law, no person shall park an unlicensed vehicle, trailer, object or other thing in any municipal parking lot or on any highway, unless specifically authorized by the Municipal Law Enforcement Officer.
- 4.14 Notwithstanding Section 4, Subsection 4.3, 4.4, 4.5 or 4.6 of this By-law, any person may apply to the Municipal Law Enforcement Officer for a parking permit to allow the vehicle operator to park in any municipal parking lot designated by this By-law and, if such parking permit is granted and the prescribed fee is paid, the vehicle displaying the parking permit may occupy any of the individual parking spaces within said municipal parking lot without using the Parking Ticket Dispenser, provided that said vehicle does not remain in said individual parking space are for a period longer than the maximum time permitted by the machine for that individual parking space;
  - 4.14.1 Where the permit referred to in subsection 14.4 above, is purchased using the Electronic Payment through an Electronic Payment "App." and the purchase is confirmed by electronic record to the purchaser and the Town, neither a Validation Ticket printed from a parking ticket dispenser, nor a physical "paper' copy is required to be displayed.
  - 4.14.2 A municipal law enforcement officer is authorized to issue and cancel a Resident Parking Permit as necessary.

4.14.3 Where a Resident Parking Permit has been obtained under this By-law, no person shall fail to comply with the terms and conditions of the said permit.

4.15 Resident Parking Permit shall be in the form prescribed by the Town and the conditions on these permits may change from time to time.

#### 5 PENALTIES:

- 5.1 Where a vehicle is found parked or in contravention of the provisions of the Bylaw, the Town may attach a notice to the vehicle saying:
  - 5.1.1 The license number of the vehicle;
  - 5.1.2 That the vehicle has violated the provisions of the By-law;
  - 5.1.3 The date, time, place and nature of the alleged offences;
  - 5.1.4 Details regarding the screening process.
- 5.2 Should a violation of this By-law continue in excess of two (2) hours, the Municipal Law Enforcement Officer may charge the violator with a second offence, and subsequently charge further offences every two (2) hours thereafter until the violation ceases.
- 5.3 The Municipal Law Enforcement Officer, upon finding a vehicle violating any section of the By-law, may in their sole discretion, order the removal of the vehicle violating the By-law when deemed necessary.
- 5.4 Any person who contravenes any provision of this By-law is subject to the Town's AMPS By-law, and is subject to other enforcement measures and administrative fees, as provided by O.Reg 333/07.

## 6 OBSTRUCT:

- 6.1 No person shall hinder or obstruct, or attempt to hinder or obstruct, any person exercising a power or performing a duty under this By-law.
- 6.2 Any person who has been alleged to contravene any section of this By-law and who fails to identify themselves is deemed to hinder or obstruct a person exercising a power or performing a duty under this By-law.

#### 7 ILLEGAL CAR RALLIES:

7.1 Where the Town has determined that an unsanctioned or illegal car rally, as defined in the Car Rally By-law, is taking place, no vehicle is permitted to Park, Stand, or Stop within the area where the Car Rally is occurring.

#### 8 VALIDITY:

8.1 Should any section, subsection, clause, paragraph, or provision of this By-law, including any section or part of Schedule "A" or Schedule "B" attached to this By-law, be declared by a Court of competent jurisdiction to be invalid or illegal for any other reason, such as offending section or part shall be deemed to have severed from this By-law and the remaining sections or parts shall continue in full force and effect and shall remain valid and binding.

#### 9 DELEGATION

9.1 The Director is authorized to make minor housekeeping amendments to this By-law that that do not alter the meaning or intent in any way.

#### 10 RESCINDING OF PREVIOUS BY-LAWS:

10.1 That By-law #2005-17 is hereby rescinded.

#### 11 EFFECTIVE DATE OF BY-LAW:

11.1 This By-law shall come into full force and take effect on the date of its passing.
